Za možnosť prijímania platobných kariet cez internet nebudete platiť žiadne zriaďovacie ani iné prevádzkové poplatky. Za služby spojené s prijímaním platobných kariet VISA a MasterCard hradí klient fixný poplatok uvedený vyššie. Tento poplatok je tvorený Interchange fee a Scheme fee, ktorých hodnota sa mení podľa typu a pôvodu karty (Nariadenie Európskeho parlamentu a Rady (EÚ) 2015/751 o výmenných poplatkoch za platobné transakcie viazané na kartu) a Acquiring fee, ktorý sa uhrádza spracovateľovi karty. Po dohode s klientom môžu byť spomínané poplatky zlúčené pre zrejmejšiu a jednoznačnejšiu komunikáciu do jedného fixného poplatku, ktorý uvádzame v Sadzobníku poplatkov ako "Poplatok za platbu".

You will not pay any setup or other operating fees for the possibility of accepting payment cards over the Internet. For services related to the acceptance of VISA and MasterCard payment cards, the client pays the fixed fee mentioned above. This fee consists of an Interchange fee and a Scheme fee, the value of which varies according to the type and origin of the card (Regulation (EU) 2015/751 of the European Parliament and of the Council on interchange fees for card-linked payment transactions) and an Acquiring fee paid to the card processor. After the agreement with the client, the mentioned fees can be combined for a clearer and more unambiguous communication into one fixed fee, which we state in the Fee Schedule as "Payment Fee".
