

INFORMATION ON THE PROCESSING OF PERSONAL DATA
CLIENT ACCOUNT

1. Purpose of processing personal data::

The purpose of the <http://www.payout.one> portal is a service provided by the operator in the field of payment services. Depending on the scope of the data provided by the registered client, the registered client will have limited or full access to the functions and options of the client account. Full access allows him/her to use the services within the meaning of the GTC.

The personal data of the data subjects are processed after registration on the <http://www.payout.one> platform. By registering on the platform, a pre-contractual relationship is established between the client and the platform operator. By using the platform, the client agrees to the GTC, which determine the terms and conditions of the payment services.

2. Legality of the processing of personal data:

Personal data is processed on the basis of legitimate interest pursuant to Article 6(1)(f) of Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation).

3. Legal obligation to process personal data:

The processing of personal data is not carried out on the basis of a legal obligation.

4. List of personal data:

The minimum personal data required to register a restricted client account are: email address, first and last name, phone number and the chosen login password.

Operational data generated by the use of services by clients and which is necessary to process to ensure the operation of the service provided. This data may be: data on the use of the service, communication with the operator, signed contractual documentation.

5. Affected persons:

Clients of the controller who register to the controller's web portal and/or use other services of the controller; potential client of the controller.

6. Storage periods for personal data:

As long as the services of the platform have not been used, the data subject can delete his or her data at any time in the profile settings. The profile is also automatically deleted after a period of 5 years during which there has been no activity of the data subject on the platform. By using the <http://www.payout.one> service on the platform, a record has been created which must be kept by the controller for the duration of the general limitation period or is kept on the basis of the legal obligation referred to in point (b).

7. Legitimate interest of the controller:

The legitimate interest of the controller is the registration on the portal <http://www.payout.one> and the service provided by the controller in the field of payment services. Depending on the scope of the data provided by the registered client, the registered client will receive limited or full access to the functions and options of the client account. Full access allows him/her to use the services within the meaning of the GTC.

8. Transfer of personal data to third countries:

Personal data is not transferred to third countries.

9. Automated individual decision-making and profiling:

There is no automated individual decision-making and profiling in the processing of personal data.

10. Technical and organisational security measures:

Organisational and technical measures for the protection of personal data are elaborated in the internal rules of the controller. Security measures are implemented in the areas of physical and object security, information security, cryptographic protection of information, personnel, administrative security and protection of sensitive information, with well-defined powers and duties specified in the security policy.
